What does the Fund invest in?

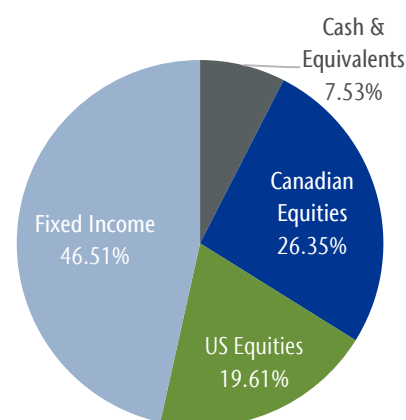
The Fund seeks to generate current income while preserving capital. The Fund is expected to provide modest potential for growth of capital over time with limited variability of returns from year to year. The Fund is broadly diversified across different types of fixed income and equity securities to increase stability. Equity securities are employed to offset the risk presented by inflation and to provide the potential for capital growth. Exposure to foreign markets will generally not be more than approximately 30%, but may be up to 49%.

The charts below give you a snapshot of the Fund's investments on January 31, 2025. The Fund's investments will change.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much of a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

CC&L Funds has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

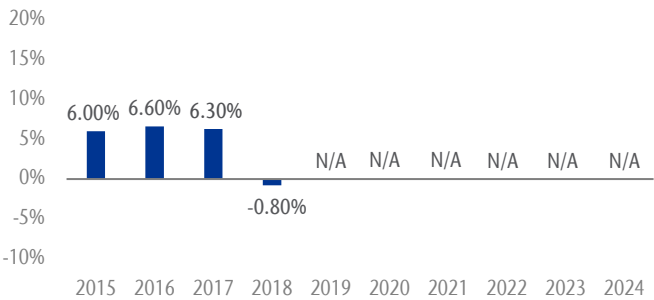
Like most mutual funds, this Fund doesn’t have any guarantees. You may not get back the money you invest.

How has the Fund performed?

This section tells you how Series I units of the Fund have performed over the past ten calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund’s returns.

Year-by-year returns

This chart would generally show how Series I units of the Fund performed in each of the past ten completed calendar years. However, year-by-year returns for Series I units have not been presented for 2019, 2020, 2021, 2022, 2023 or 2024 because Series I units were not outstanding for a full calendar year. The Fund dropped in value in one of the past ten completed calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table would generally show the best and worst returns for Series I units of the Fund in a 3-month period over the past ten completed calendar years. However, the best and worst 3-month returns are only being presented for the years 2010-2018, since Series I units were not outstanding for a full calendar year in 2019, 2020, 2021, 2022, 2023 or 2024. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compound return of Series I units of the Fund has not been presented because no Series I units have been outstanding since August 7, 2019.

Who is this Fund for?

Investors who:

- want a diversified, balanced portfolio of fixed income and equity;
- are willing to accept low to medium risk;
- are investing over the medium to long term; and
- seek to generate income.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following shows the fees and expenses you could pay to buy, own and sell Series I units of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You may have to pay a sales charge when you buy Series I units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. The Fund's expenses are made up of the operating expenses and trading costs. Because no Series I units are issued or outstanding, the operating expenses and trading costs are not available.

No trailing commissions are payable in respect of Series I units of the Fund.

How much does it cost? cont'd

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	2% of the value of units you sell or switch to another fund within 30 days of buying them. This fee goes to the Fund.
Dishonoured cheques or insufficient funds	We reserve the right to charge a fee for such transactions.
Switch fees	We do not charge switch fees, however your representative may charge you a switch fee when you switch units of the Fund.
Representative fees	You may have to pay your representative advisory fees negotiated between you and your representative.
Management fee	Fees for services of CC&L PC payable by Series I investors for the Portfolio are negotiable by the investor and are payable directly to CC&L PC and will not exceed 1.00%.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
