## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Results of Operations

As at June 30, 2026, the CC&L Global Market Neutral II Fund (the “Fund”) held \$286.3 million in total net assets. During the period, investors in Series A units in the Fund experienced a return of 5.79%. The benchmark for the Fund (CANCASH (0%)) returned 0.00% over the same period. The performance of the different series within the Fund will vary due to the differences in their expense structures. For specific returns by series, please refer to the “Past Performance” section of this report. In March 2026, the Manager announced a limited closure of the Fund to purchases by new investors, effective March 13, 2026, to preserve the integrity and return potential of the Fund's investment strategy. Existing investors may continue to make additional purchases subject to the terms of the limited closure.

The Fund's Net Assets increased by 21.9% or \$51.5 million during the period, from \$234.8 million on January 1, 2026, to \$286.3 million on June 30, 2026. This change in Net Assets resulted from an increase of \$36.1 million due to net subscriptions and an increase of \$15.4 million due to investment operations, including market volatility, income and expenses.

Global equity markets experienced significant turmoil as President Trump's higher-than-expected tariff announcements triggered sharp selloffs. However, as the quarter progressed, market sentiment improved meaningfully. A temporary easing in trade tensions, along with resilient corporate earnings and stronger-than-expected economic data, reduced recession concerns and supported a broad recovery in risk assets. Global sector performance reflected the improvement in investor sentiment, with cyclical sectors, on average, outperforming defensive sectors. Technology and Communication Services emerged as the top performing global sectors in the second quarter, while Health Care and Energy were the weakest performers.

Global equity markets rallied as easing tensions in the Middle East helped push oil prices lower and reduce stagflation concerns. Investor sentiment was further supported by resilient economic data, strong corporate earnings, and continued enthusiasm for AI-related growth. Regional performance extended year-to-date trends, with emerging markets continuing to outperform other regions. At the global sector level, Technology led by a wide margin, while Energy lagged.

Growth metrics in our model have been strong, reflecting generally persistent intermediate- to long-term price trends and positive contributions from fundamental stock-level growth indicators. Value also outperformed, as stocks priced attractively relative to their underlying fundamentals were rewarded. Quality was similarly strong, with metrics linked to earnings sustainability and balance sheet health rewarded in the marketplace. Opportunity composites also contributed positively, as Efficiency and Complexity performed above long-term expectations, while Structural was broadly in line with long-term expectations.

The portfolio delivered a strong positive return in the first half of 2026. Both security selection and country-sector allocation contributed positively to performance. Security selection within Korean industrials and Taiwanese technology were the notable contributors. In particular, stock picking within Korean electrical components & equipment companies were rewarded. From a country-sector allocation perspective, the long positions in Korean technology and Japanese technology were large contributors to performance while the long positions in French consumer discretionary detracted.

## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Leverage

Leverage occurs when the Fund borrows money or securities, or uses derivatives, to generate investment exposure that is greater than the amount invested.

The Fund's leverage is determined by calculating the aggregate exposure through the sum of following: (i) the market value of the Fund's short positions; (ii) the amount of cash borrowed for investment purposes; and (iii) the notional value of the Fund's specified derivatives positions excluding any specified derivatives used for hedging purposes. The Fund's exposure to leverage must not exceed 300% of the Fund's Net Asset Value ("NAV").

During the period ended June 30, 2026, the Fund's aggregate exposure to leverage ranged from 141.8% to 155.3% of the Fund's NAV. The aggregate exposure range to leverage was within the expected range as outlined in the simplified prospectus. As at June 30, 2026, the Fund's aggregate exposure was 147.6% of the Fund's NAV. The primary sources of leverage were short positions in equity securities, short equity swap contracts and cash borrowing.

A component of the Fund's leverage is cash borrowing. Such facilities are repayable on demand. During the period ended June 30, 2026, the Fund's range of cash borrowing was \$0 to \$13,215,248. As at June 30, 2026, cash borrowing represented 0.4% of the Fund's NAV.

## MANAGEMENT DISCUSSION OF FUND PERFORMANCE

### Recent Developments

The overall level of investment opportunity across our model – as measured by the dispersion of return forecasts – is above its long-term average, driven by relatively high opportunity in Growth, Efficiency, and Complexity factor groups. Portfolio exposures to Opportunity factor groups increased on a relative basis over the quarter, driven primarily by higher opportunity levels in Complexity.

### **Related Party Transactions**

CFI is affiliated with Connor, Clark & Lunn Financial Group Ltd. As disclosed in the prospectus and annual information form, the portfolio manager retained by the Fund, Connor, Clark & Lunn Investment Management Ltd., is also affiliated with Connor, Clark & Lunn Financial Group Ltd. During the period ended June 30, 2026, no additions or deletions were made to the portfolio managers providing services to the Fund.

As Manager, CFI receives management and performance fees with respect to the day-to-day business and operations of the Fund as described in the section entitled “Management and Performance Fees”. These management and performance fees are charged in the normal course of business and are measured at their exchange amount, which approximates that of an arm’s length transaction.

(3) The Manager of the Fund, CC&L Funds Inc., may waive certain fees or absorb certain expenses otherwise payable by the Fund. The amount of expenses waived or absorbed is determined periodically on a series by series basis at the discretion of the manager and the manager can terminate the waiver or absorption at any time.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.

(5) The trading expense ratio represents margin interest, borrow fees on investments sold short, total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

## MANAGEMENT AND PERFORMANCE FEES

### Management Fees

The Fund is managed by CFI. As consideration for providing investment advisory and management services, CFI receives a management fee from the Fund, based on the net asset value of the respective series, calculated daily and payable monthly in arrears. In respect of units of all series of the Fund other than Series I, the management fee is paid by the Portfolio to CFI. Management fees in respect of Series I units are arranged directly and charged outside the Portfolio. Management fees on Series I units are not expenses of the Portfolio. CFI uses a portion of management fees to pay for trailing commissions to registered dealers (if applicable) based on amounts invested in the Fund. CFI uses the remaining portion of the management fees to pay for investment advice, including fees charged by the Fund's portfolio manager, and general administration expenses and retains the balance for profit. The following table summarizes the annual management fee rates (excluding GST and HST) of each series of the Fund, expressed as a percentage of the Fund's value, and the portion used for dealer compensation and the portion used for or attributed to investment advice, general administration and profit.

### Performance Fees

The Fund pays a quarterly performance fee to the Manager, calculated and accrued daily. The performance fee is 20% of the net positive return of the Series for the Performance Period, subject to a perpetual high-water mark. The performance fee is applicable to Series A and Series F units. Unitholders of Series I units may negotiate a performance fee to be paid by the investor directly to the Manager.

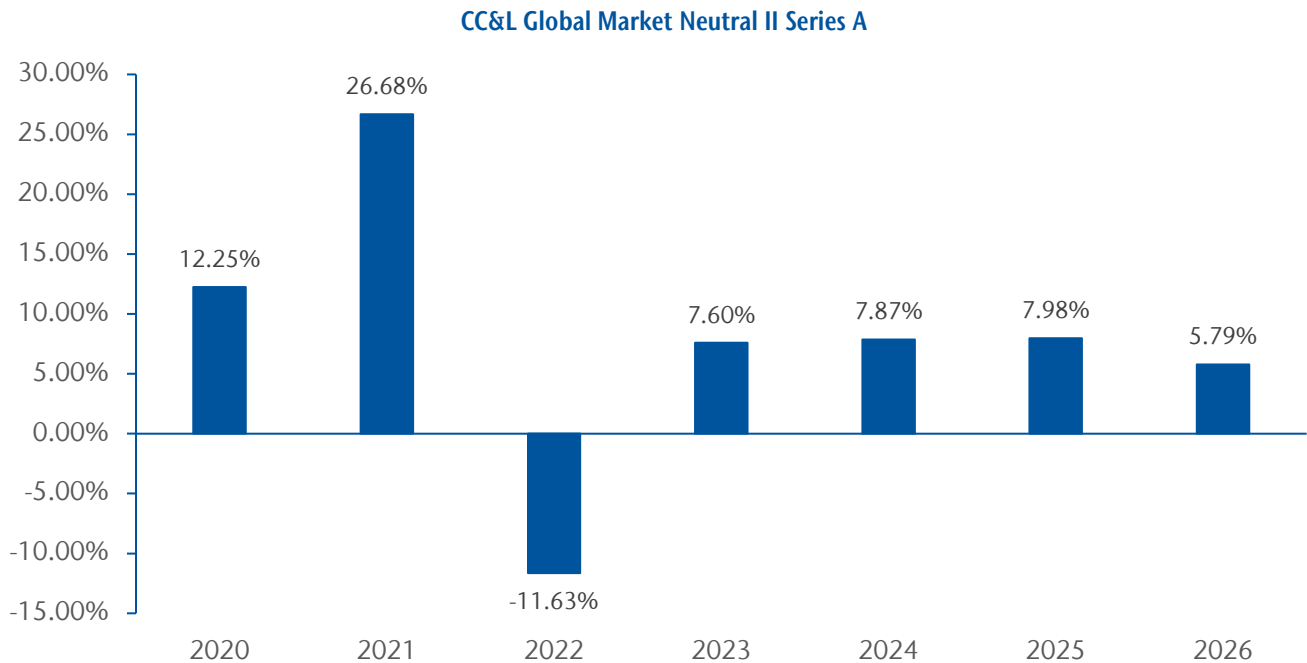

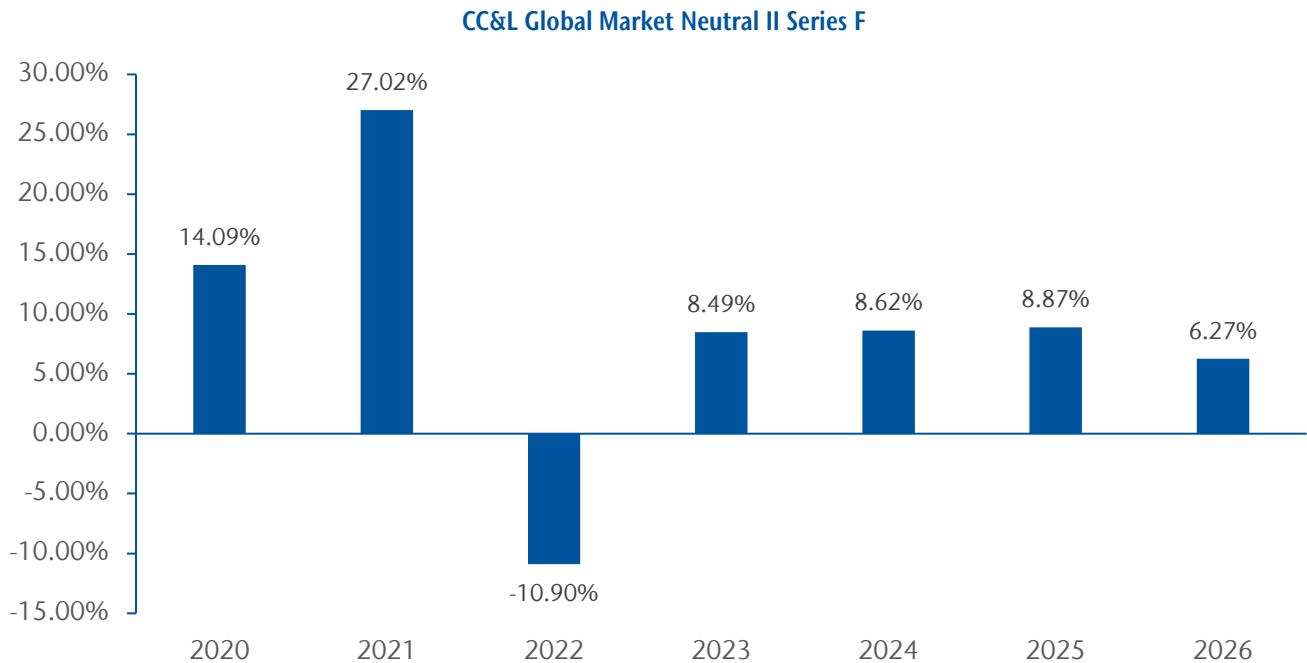

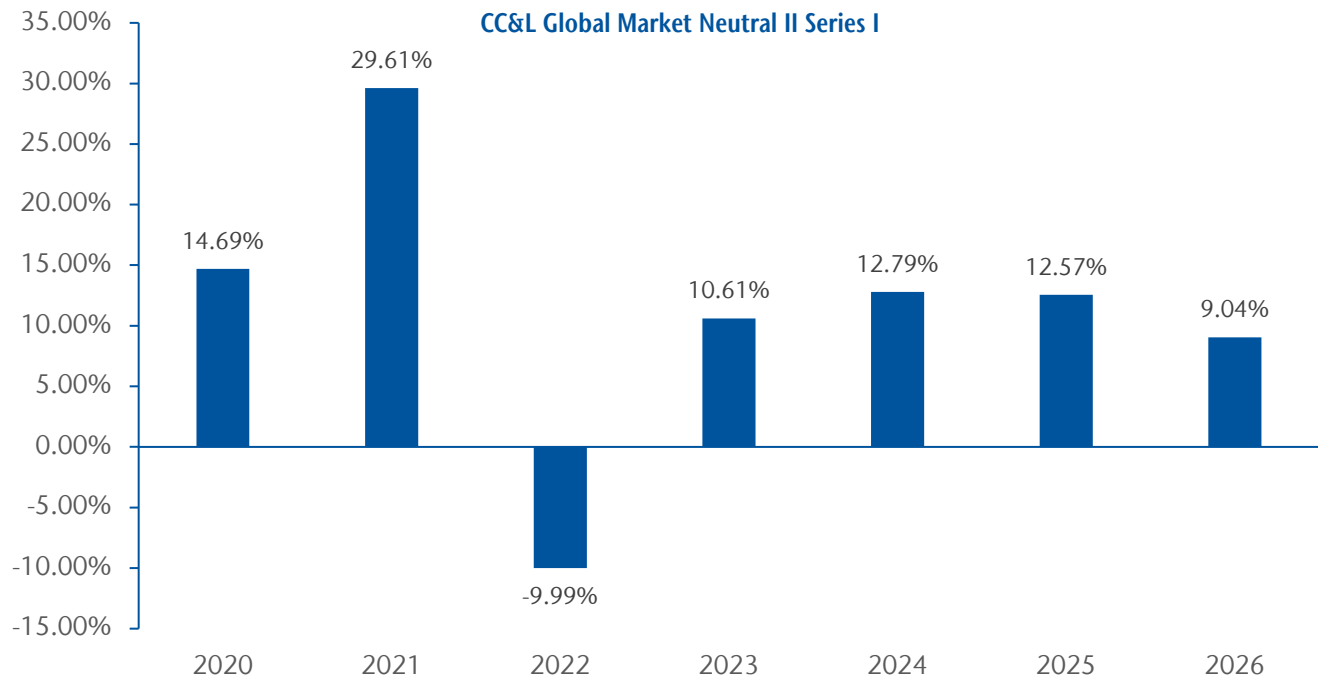
## PAST PERFORMANCE

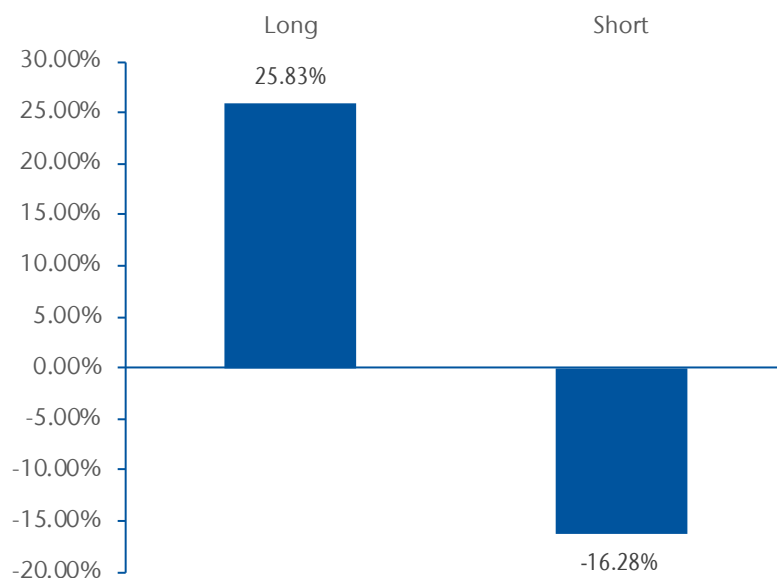
### Year-by-year Returns
